**FIFTH AMENDMENT TO AN INTERLOCAL CONTRACT
BETWEEN DOUGLAS COUNTY,

This fifth amendment of a previously approved interlocal contract is made by and between Douglas County (County), the Tahoe-Douglas Transportation District (TDTD), and the Tahoe Transportation District (TTD).

AMENDMENT

1. Paragraph 1 of the interlocal contract is amended to read as follows:

This interlocal contract was originally approved by the TTD on February 13, 1998, and by the Douglas County Board of Commissioners on February 19, 1998. The second amendment extended the contract time through December 31, 1999. The third amendment extended the time through December 31, 2000. The fourth amendment extended the contract time through December 31, 2001. This fifth amendment extends the contract time through December 31, 2002, unless sooner terminated in accordance with ¶ 3 or unless extended by the written agreement of the parties.

- 2. County will pay to the TTD the cost of transit services provided by Area Transit Management during the calendar year 2002, plus \$200 per month for contract administration by the TTD, for a total estimated cost to the County of \$130,065. Funding for the contract has been established through the County's 5-Year Transportation Plan.
- 3. All other terms of the interlocal agreement remain unchanged and in effect.
