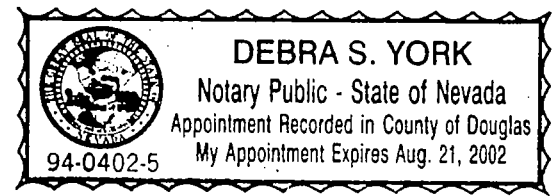

thence North 02°43'50" East, a distance of 242.00 feet;  
thence South 84°00'03" East, a distance of 449.60 feet to a point on the Westerly right-of-way line of Centerville  
Lane;  
thence South 00°02'30" East along the Westerly right-of-way line of Centerville Lane, a distance of 195.00 feet  
to a point on a curve;  
thence along the Westerly right-of-way line of Centerville Lane along a curve to the right with an initial tangent  
of South 00°02'30" East with a radius of 960.00 feet, through a central angle of 06°37'59" and an arc  
length of 111.14 feet (Long Chord South 03°16'29" West, a distance of 111.08 feet);
