PARCEL 2

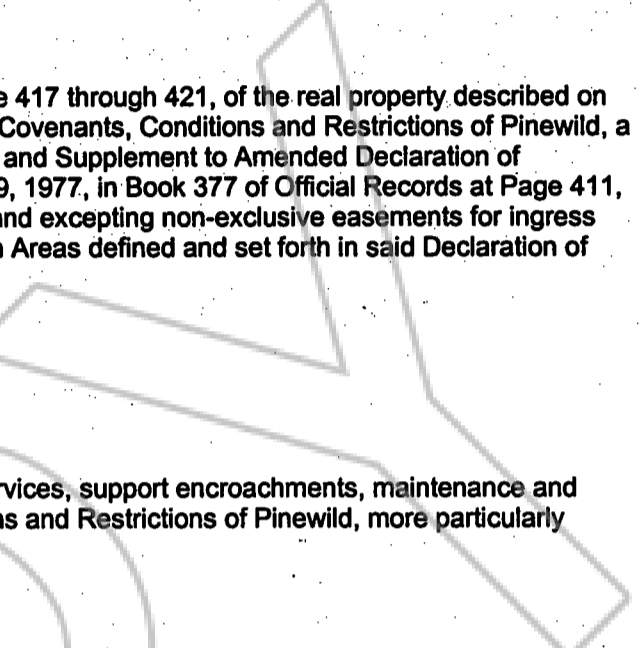
