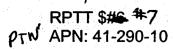
# **GRANT, BARGAIN AND SALE DEED**

A Time Share interest comprised of the following:

#### PARCEL OME:

An undivided 1/51st interest in and to that certain condominium estate described as follows:

A non-exclusive right to use the "Special Common Area" as defined, and for the purposes and on the terms and conditions set forth, in that certain Declaration of Annexation (Tahoe Summit Village) and Grant, Bargain and Sale Deed recorded May 27, 1987 in Book 507 at Page 2664 as Document No. 155368, Official Records of Douglas County, State of Nevada during and for the "Use Period" set forth in subparagraph (a) above.

#### PARCEL THREE:

A non-exclusive right to use the real property known as Common Area on the Official Map of Tahoe Summit Village Unit Mo. 2, recorded March 29, 1974 as Document Mo. 72495, Official Records of Douglas County, State of Nevada, as amended and modified, for all those purposes provided for in the Declaration of Covenants, Conditions and Restrictions recorded January 11, 1973 as Document Mo. 63681, Official Records of Douglas County, State of Mevada, and as amended by instruments recorded with said County and State on September 28, 1973 as Document Mo. 69063 in Book 973, Page 812 and July 2, 1976 as Document Mo. 01472 in Book 776, Page 87 of Official Records of Douglas County, State of Mevada during and for the "Use Period" set forth in subparagraph (a) above.

The above described exclusive and non-exclusive rights may be applied to any available unit in the project during said Use Period within said Season.

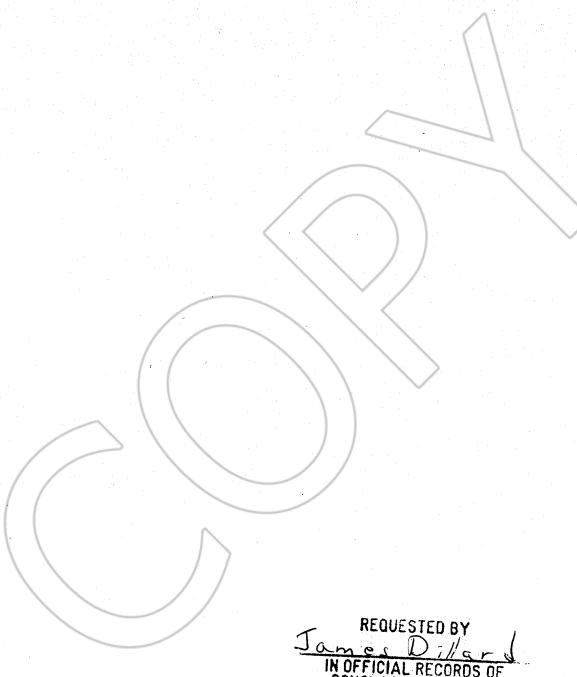
