BOB C. GRIFFO, as Trustee of the BOB C. GRIFFO REVOCABLE TRUST, originally executed on February 7, 2002



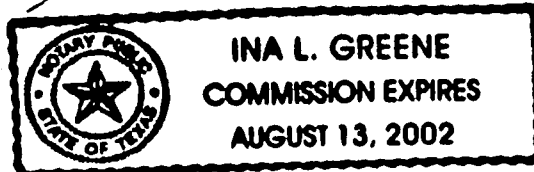
