The Motion of Defendants and Counterclaimants Donald E. Brooks and Lynette L. Brooks, Trustees of the Brooks Family Trust ("Brooks Trust") For Entry of Default and Default Judgment against Unknown Counterdefendants With Affidavit Attached ("Motion") came before this Court for hearing on 31 May 2001 at 10:00 a.m. Present on behalf of the Brooks Trust was Michael L. Matuska. Present on behalf of the Plaintiff Washoe Tribe of Nevada and California was Evan Beavers. Upon consideration of the Motion, supporting affidavit and oral argument presented at the hearing, and for good cause shown, it hereby ordered that:

The Brooks Trust's Motion For Entry of Default and Default Judgment against Unknown Counterdefendants With Affidavit Attached is Granted. Judgment is hereby entered on the Brook Trust's counterclaim in favor of the Brooks Trust and against all persons unknown claiming any right, title, estate, lien or interest adverse to the Brooks Trust's ownership, or any cloud upon Brooks Trust's title to the real property described as follows:

> All that real property located in Douglas County Nevada, situated in the Southwest 1/4 of the Northwest 1/4 of Section 14 of Township 12 North, Range 20 East, Mount Diablo Base & Meridian, said real property lying to the South and West of the East Branch of the Carson River, excluding that real property depicted on the Official Plat Map of Gardnerville Ranchos Unit 3 as filed in the Official Records of Douglas County, Nevada as document number 28310 (amended 4 June 1965 by document number 28378), together with all and singular tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the rents, issues and profits thereof, including those Carson River surface water rights identified as Claim No. 138. (A portion of A.P.N. 1220-14-000-001)

The Brooks Trust's Motion for Certification as Final Judgment is denied without prejudice. No final judgment against Unknown Counterdefendants will be entered until the case is finally resolved as to the Washoe Tribe. This Order does not affect the pending
