DECLARATION OF HOMESTEAD

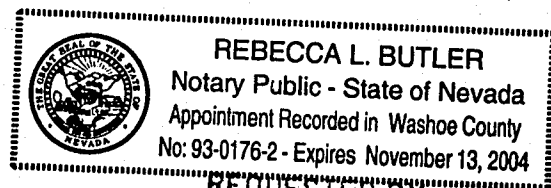
