TEMPORARY EASEMENT DEED

THIS DEED made this 10th day of July, 2001 between Paul C. Goddard Trustee and Barbara T. Goddard Trustee, under the terms of such Declaration of Trust, hereinafter called GRANTOR, and the STATE OF NEVADA, acting by and through its Department of Transportation, hereinafter called GRANTEE,

WITNESSETH:

That the GRANTOR, for and in consideration of the sum of ONE DOLLAR (\$1.00), lawful money of the United States of America, and other good and valuable consideration, the receipt whereof is hereby acknowledged, does by these presents grant and convey unto the GRANTEE and to its assigns for those purposes as contained in Chapter 408 of the Nevada Revised Statutes, a temporary easement and right-of-way for the construction of drainage improvements upon, over and across certain real property of the undersigned situate, lying and being in the County of Douglas, State of Nevada, and more particularly described as being a portion of Section 10, T. 13 N., R. 18 E., M.D.M., and further described as being a portion of Lot 6 in Block "C" shown on that certain AMENDED MAP OF ZEPHYR COVE PROPERTY as Document No. 266, filed for record August 5, 1929, in the Office of the County Recorder, Douglas County, Nevada, and more fully described by metes as bounds and follows, to wit:

BEGINNING at a point on the left or southwesterly right-of-way line of US-50, 12.192 meters (40.00 feet) left of and measured radially from Highway Engineer's Station "S" 68+35.000 P.O.C.; said point of beginning further described as bearing S. 14°08'43" W. a distance of 824.302 meters (2,704.40 feet) from the north quarter corner of Section 10, T. 13 N., R. 18 E., M.D.M.; thence from a tangent which bears S. 17°50'20" W., curving to the right along said left or southwesterly right-of-way line, with a radius of 231.649 meters (760.00 feet), through an angle of 1°24'35", an arc distance of 5.700 meters (18.70 feet) to a point; thence along the following three (3) courses and distances:

- 1) N. 86°22'06" W. - 3.478 meters (11.41 feet);
- 2) N. 1°17'57" E. - 6.836 meters (22.43 feet);
- 3) S. 72°09'40" E. - 5.388 meters (17.68 feet) to the point of beginning; said parcel contains an area of 27 square meters (294 square feet).

The temporary easement rights granted by this instrument shall terminate effective May 1, 2005.

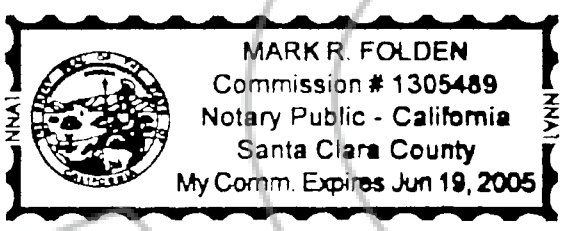
