It is mutually agreed and understood by the STATE and by the OWNER that the herein agreed to temporary easement(s) are granted for the purpose of Project SPSR-00206(002) and that the termination date of the said easement(s) has been established in compliance with the best available information on the time frame for the Project SPSR-00206(002). Therefore, it is further mutually agreed and understood by the STATE and the OWNER that, when the STATE determines that circumstances warrant a reasonable extension of the termination of the rights under the temporary easement, such an extension shall be granted at the rate established by this agreement.

TO HAVE AND TO HOLD all and singular the said real property, together with the appurtenances, unto the said GRANTEE and to any heirs, successors and assigns for the term of this temporary easement deed.
