**The Ridge Tahoe, Naegle Building, Winter Season, Week #31-092-36-01, Stateline, NV 89449**

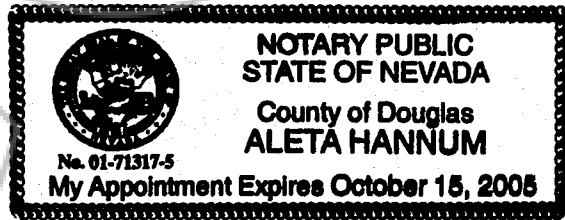

Except therefrom units 081 to 100 Amended Map and as corrected by said Certificate of Amendment.
- (b) Unit No. 092 as shown and defined on said last mentioned map as corrected by said Certificate of Amendment.
