NOTICE OF LIEN CLAIM

NOTICE IS HEREBY GIVEN that:

1. William F. Heckman, General Contractor, dba The Homeworks Construction, hereby claims a mechanic's lien pursuant to the provisions of NRS 108.221, et seq., laws of the State of Nevada, in the amount of \$8,675.00 (eight thousand six hundred seventy-five dollars only), on the real property any improvements located on Lot 7 , as shown on the official plat of Tierra Linda Estates, filed in the office of the County Recorder of Douglas County, State of Nevada,, on September 14, 1965, in book 1 of Maps, as Document No.29457, more commonly known as 1091 Oro Way, Gardnerville, Nevada.

2. The owner or reputed owners of the above-described property are JERRY W. CLARK and TERI ANN CLARK, Trustees of the CLARK FAMILY TRUST DATED JULY 26, 1997, whose address is 1091 Oro Way, Gardnerville, Nevada.

3. This lien is claimed for materials and labor for the additions of a sunroom and a workshop at the above address.


4. Said labor and materials were supplied at the express direction and order of the owners, Jerry and Teri Clark, pursuant to the original Agreement dated February 18, 2002, and the Change Orders dated April 3, 2002, with terms and conditions which provided for payment to be made when the work was completed.

5. Ninety (90) days have not elapsed since the completion of the work or improvement on the property described above. The last date lien claimant furnished labor or materials was May 13, 2002.

6. The claimant herein is entitled to a reasonable attorney's fee, statutory interest on the amount of this lien claim, and costs incurred in perfecting this lien claim.

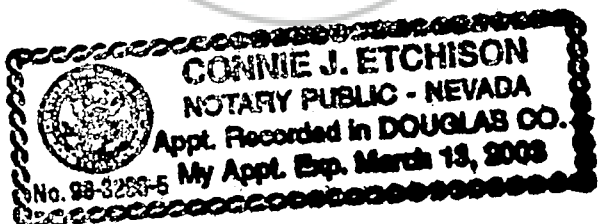
