



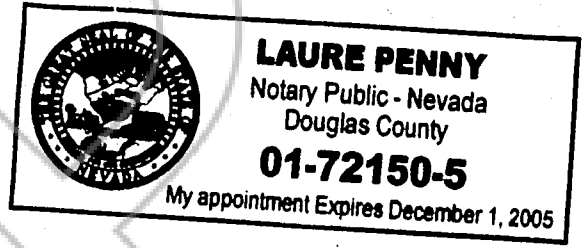

**ORDER AFTER
HEARING TO SHOW CAUSE**

12 ROBERT STEWART BELLEMORE,
13 aka Robert Steven Bellemore,

15 THIS MATTER came before the court for hearing May 7, 2002,
16 upon an application for an order to show cause by the Douglas County
17 District Attorney's office on behalf of Kellie Ann Chambers for
18 defendant Robert Stewart Bellemore to appear and show cause why he
19 should not be held in contempt of court for failing to pay child
20 support as required under this court's order issued March 16, 1998;
21 why defendant should not be confined in the Douglas County Jail for
22 a period of twenty-five (25) days for his contempt of court; and why
23 an order should not issue reducing to judgment child support
24 arrearages in the amount of \$3,625.798 through the date of hearing.

25 Defendant appeared with his employer Jeff Shunk. The
26 Douglas County District Attorney's office was represented by Evan
27 Beavers, Deputy District Attorney. Defendant explained that he had

1 worked for Mr. Shunk for eight years and was presently employed by Mr.
2 Shunk's company, Nevada Painting, at \$14 per hour. Defendant resides
3 in Gardnerville, Nevada.

4 Based upon the evidence presented and the arguments offered
5 the court finds that Robert Stewart Bellemore, aka Robert Steven
6 Bellemore, is in contempt for failure to pay child support pursuant
7 to this court's order of March 16, 1998, and

8 IT IS HEREBY ORDERED as follows:

9 1. That defendant's arrears through the date of this
10 hearing in the amount of \$3,625.78 are reduced to judgment;

11 2. That defendant Robert Stewart Bellemore, aka Robert
12 Steven Bellemore, shall be sentenced to twenty (20) days incarceration
13 in the Douglas County jail for contempt, which sentence is suspended
14 for each month defendant continues to pay the on-going child support
15 and arrears under the following terms and conditions:

16 a. Defendant shall pay the sum of \$189.78 on or before
17 May 10, 2002;

18 b. Defendant shall pay the sum of \$189.78 as ongoing
19 support plus \$36 toward arrears on or before the 15th
20 day of each month thereafter;

21 3. That defendant shall provide the Douglas County District
22 Attorney's Child Support office with his current phone number,
23 physical address, mailing address and employment information at all
24 times;

25 4. Payments must be sent to:

PAYMENTS MUST BE BY MONEY ORDER, CASHIER'S CHECK
OR BUSINESS CHECK AND PAYABLE TO SCaDU.

1 The following information must be included with each payment:

- 2 1. Name (first, middle, last) of the person responsible
3 for paying child support;
4 2. Social Security Number of the person responsible for
5 paying child support;
6 3. Child support case number, if applicable;
7 4. Name of the custodian (first and last name of person
8 receiving child support).

8 FAILURE TO COMPLY WITH THE TERMS AND CONDITIONS SET OUT ABOVE WILL
9 RESULT IN THE DEFENDANT'S IMMEDIATE INCARCERATION FOR A PERIOD OF
10 TWENTY (20) DAYS FOR EACH VIOLATION OF THE ABOVE TERMS OF PAYMENT.
