THIS MATTER came before the court for hearing May 7, 2002, upon an application for an order to show cause by the Douglas County District Attorney's office on behalf of Kellie Ann Chambers for defendant Robert Stewart Bellemore to appear and show cause why he should not be held in contempt of court for failing to pay child support as required under this court's order issued March 16, 1998; why defendant should not be confined in the Douglas County Jail for a period of twenty-five (25) days for his contempt of court; and why an order should not issue reducing to judgment child support arrearages in the amount of \$3,625.798 through the date of hearing.

Defendant appeared with his employer Jeff Shunk. The Douglas County District Attorney's office was represented by Evan Beavers, Deputy District Attorney. Defendant explained that he had

worked for Mr. Shunk for eight years and was presently employed by Mr. Shunk's company, Nevada Painting, at \$14 per hour. Defendant resides in Gardnerville, Nevada.

Based upon the evidence presented and the arguments offered the court finds that Robert Stewart Bellemore, aka Robert Steven Bellemore, is in contempt for failure to pay child support pursuant to this court's order of March 16, 1998, and

IT IS HEREBY ORDERED as follows:

- 1. That defendant's arrears through the date of this hearing in the amount of \$3,625.78 are reduced to judgment;
- 2. That defendant Robert Stewart Bellemore, aka Robert Steven Bellemore, shall be sentenced to twenty (20) days incarceration in the Douglas County jail for contempt, which sentence is suspended for each month defendant continues to pay the on-going child support and arrears under the following terms and conditions:
 - a. Defendant shall pay the sum of \$189.78 on or before May 10, 2002;
 - b. Defendant shall pay the sum of \$189.78 as ongoing support plus \$36 toward arrears on or before the 15th day of each month thereafter;
- 3. That defendant shall provide the Douglas County District Attorney's Child Support office with his current phone number, physical address, mailing address and employment information at all times;
