- 4. The assets of the Decedent, as of the date of death, do not exceed \$50,000.
- 5. Petitioner has no knowledge of any liens or encumbrances against the Decedent's property and there are no liens or encumbrances of record against the Decedent's property.
- 6. The final income tax return for Decedent has been filed. It is not necessary to file a fiduciary tax return for Decedent's estate.
 - 7. Article Fifth of the Will of the Decedent provides as follows:
