ABANDONMENT: DA 01-066

AN ORDER OF ABANDONMENT VACATING A 30-FOOT PUBLIC ACCESS EASEMENT FROM EAST VALLEY TO SAWMILL AND A 50-FOOT WIDE PUBLIC ACCESS EASEMENT ALONG STILLWATER AND COTTONTAIL ROADS FROM THE INTERSECTION OF SAWMILL ROAD EAST ALONG STILLWATER AND NORTH ALONG COTTONTAIL.

WHEREAS Douglas County, a political subdivision of the State of Nevada, presently holds an easement interest within the Southwest ¼ of the Southeast ¼ of Section 26, Township 13 North, Range 20 East, M.D.B. & M., further described as a portion of Lot 9 & 10 as shown on that record of Survey Map, Document No. 51917, as modified by the realignment of East Valley Road as shown on that Record of Survey, Document No. 178318, both on file in the official records of Douglas County, Nevada, being more particularly described as follows:

The southerly 50-feet of the above-described portion of Lot 9, bounded easterly by the easterly line of Lot 9, said line being also the east line of said southwest ¼ of the southeast ¼ of Section 26, and bounded westerly by the westerly line of said Lot 9, said line being also the westerly line of said southeast ¼ of the southeast ¼ of Section 26.

The easterly 50-feet of the above-described portion of Lot 9, bounded northerly by the northerly line of Lot 9, and bounded southerly by the southerly line of said Lot 9, said line being also the southerly line of said southeast ¼ of the southeast ¼ of Section 26.

The southerly 30-feet of the above-described portion of Lot 10, bounded easterly by the easterly line of said southwest ¼ of the southeast ¼ of Section 26, and bounded westerly by said realignment of East Valley Road.

WHEREAS Douglas County, pursuant to the provisions of NRS 278.480 may vacate or abandon by formal order any portion of a public roadway which is in excess of its needs; and,

WHEREAS on September 11, 2001, the Douglas County Planning Commission held a public hearing in conformance with the provisions of NRS 278.240 to take testimony for said abandonment and did find that the release of the aforesaid described easement was not inconsistent with the Douglas County Master Plan; and,

WHEREAS on October 4, 2001, the Douglas County Board of Commissioners held a public hearing to take testimony for said abandonment and did find that the subject easement is in excess of the needs of Douglas County, and that the public will not be materially injured by the abandonment.


