CERTIFICATE OF AMENDMENT

TO

DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

FOR

GENOA LAKE ASSOCIATION

THIS AMENDMENT to the Declaration of Covenants, Conditions and Restrictions ("CC&Rs") for Genoa Lake Association (the "Association") is made this 15th day of April , 2002, with reference to the following facts:

- A. The Association's CC&Rs were recorded as Book No. 393, Instrument No. 302138 in the official records of the County Recorder's Office of Douglas County, Nevada on March 16, 1993, and encumbers that certain property as shown on Exhibit "A" attached hereto and incorporated herein by this reference;
- B. The Association is a non-profit corporation, subject to Nevada Revised Statute 116 ("NRS 116"). NRS 116 was amended effective October 1, 1999, by Senate Bill 451.
- C. The amendments added to NRS 116 by Senate Bill 451 require certain amendments to the Association's governing documents, including, but not limited to, its CC&Rs. Pursuant to the terms of NRS 116, the Board of Directors, without a required vote of the homeowners, has the right to amend the CC&Rs to comply with NRS 116, as amended.
- D. The Board of Directors, by a resolution, adopted at a duly called, properly notice Board Meeting approved the following amendments to the CC&Rs to comply with NRS 116, as amended.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING:

1. Article II, Section 2.04.E of the CC&Rs is hereby deleted in its entirety and replaced with the following:

- "E. <u>Proxy Voting</u>. The use of proxies shall be governed by the Association's Bylaws."
- 2. Article II, Section 2.05 of the CC&Rs is hereby deleted in its entirety and replaced with the following:
 - "2.05 <u>Meetings of Members</u>. Meetings of Members shall be governed by the Association's Bylaws."
 - 3. The following shall be added to the CC&Rs as Article XI:

"ARTICLE XI Reserves

- 11.1 The Association shall establish an adequate reserve funded on a reasonable basis, for the repair, replacement or restoration of the major components of the common elements. The reserve may be used only for those purposes, including, without limitation, repairing, replacing and restoring roofs, roads and sidewalks, and must not be used for daily maintenance.
- 11.2 The Association shall:
- a. Cause to be conducted at least once every five years, a study of the reserves required to repair, replace and restore the major components of the common elements:
- b. Review the results of that study at least annually to determine if those reserves are sufficient; and
- c. Make any adjustments it deems necessary to maintain the required reserves."
- 4. Except as the same is hereinabove amended, the CC&Rs, and each and every provision thereof, shall continue in full force and effect.


