**DEED OF APPOINTMENT OF SUBSTITUTE TRUSTEE**

THIS DEED OF APPOINTMENT OF SUBSTITUTE TRUSTEE, made this day June 9, 2002, CTX MORTGAGE COMPANY (hereinafter referred to as "Noteholder"), holder in due course of a certain Promissory Note secured by a Deed of Trust from MARK CONTRERAS AND ROXANNE CARMICHAEL, dated August 10, 2000, and recorded August 21, 2000, among the Land Records of the State of Nevada as Book 0800 Page 3680 Document # 0498028, and was given to secure a loan evidence by Promissory Note payable to CTX MORTGAGE COMPANY, WHEREAS, said Deed of Trust is secured on real property situated in the State of Nevada and described as follows:

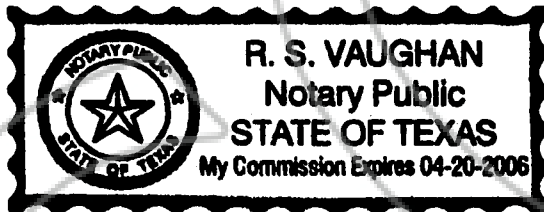
