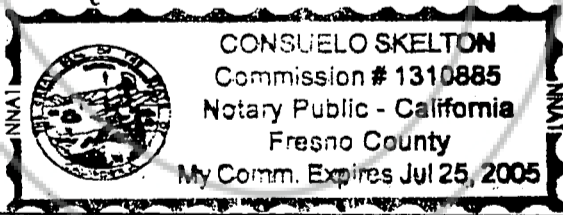

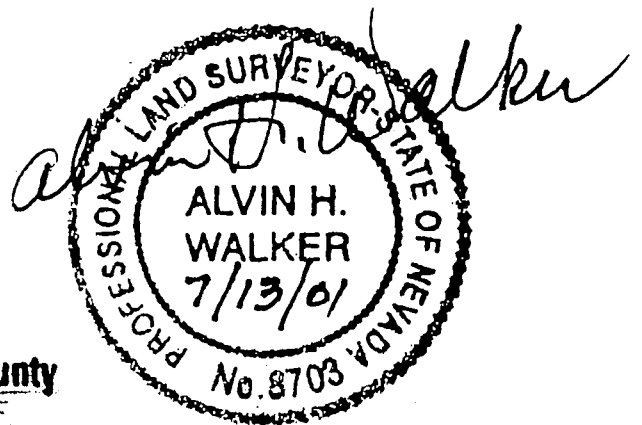
Thence along said southerly line of Genoa Lane S 71° 31' 30" E, 369.58 feet to a set 5/8" rebar and cap, "PLS 8703";
