**STIPULATION FOR ENTRY OF JUDGMENT**

IT IS HEREBY STIPULATED AND AGREED by and between FIRST SELECT, INC., ("Plaintiff"), and STEVEN P. DRIES, ("Defendant(s)"), that Judgment be entered in favor of the Plaintiff and against the Defendant(s) for the amount of \$2,236.01, plus interest on the principal balance in the amount of \$129.02, along with Plaintiff's costs of suit in the amount of \$104.00, and Plaintiff's attorney's fees in the amount of \$250.00, together with interest on the principal balance at the mutually agreed contract rate of 18% per annum from April 10, 2002 until this debt is paid in full.

The Defendant admits that he/she has no defenses or setoffs in this case.

It is further stipulated and agreed that this Judgment shall be paid as follows:

1. Payments shall be made in an amount of no less than \$200.00 per month by the 30th day of every month, with the first payment being due on or before April <sup>3</sup>20, 2002.

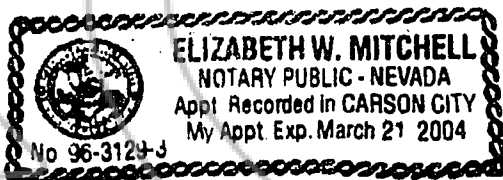


