THEREFORE, the undersigned hereby substitutes Wells Fargo Bank West, N.A. as trustee under said Deed of Trust.





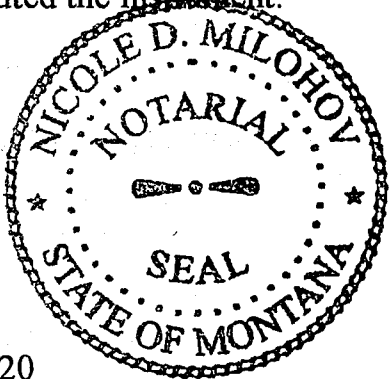
