
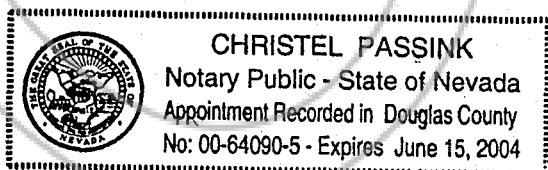

An Alternate Timeshare estate comprised of:
