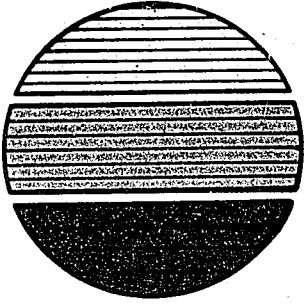

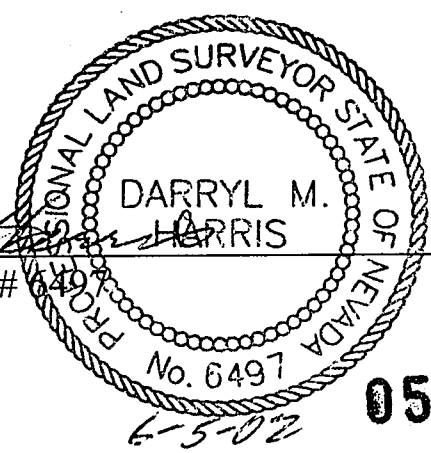
Dear Mr. Ruschmeyer:

Please be advised that the wrong Township number appears in two places on the above-referenced Parcel Map. Under the Surveyor's Certificate; Note Number 2 states "**THE LANDS SURVEYED LIE WLITHIN SECTIONS 27 & 28, T. 13 N., R. 20 E., MDB&M, AND THE SURVEY WAS COMPLETED ON FEBRUARY 22, 2002**", on the title block at the lower right hand corner of the Parcel Map "**LOCATED WITHIN A PORTION OF SECTION 27 & 28, T. 13, N., R. 20 E., MDM, DOUGLAS COUNTY**". Please omit Section 28 it is in error in both cases.

Corrected Note should read "**THE LANDS SURVEYED LIE WLITHIN SECTION 27, T. 13 N., R. 20 E., MDB&M, AND THE SURVEY WAS COMPLETED ON FEBRUARY 22, 2002** and Corrected Title Block "**LOCATED WITHIN A PORTION OF SECTION 27, T. 13 N., R. 20 E., MDM, DOUGLAS COUNTY**".
