DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR COVERAGE ASSIGNMENT ("DEED RESTRICTION")

This Deed Restriction is made this <u>25</u>th day of <u>September</u>, 2002, by Falcon Capital, LLC, a Wyoming Limited Liability Company (hereinafter "Declarants").

RECITALS

1. Declarants are the owners of certain real property located in Douglas County, State of Nevada, described as follows:

See "Exhibit A" attached hereto.

Said parcel was recorded in the Office of the County Recorder of Douglas County on October 9, 2001 in Book 1001, Page 2502 as Document Number 0524684 and having Assessor's Parcel Number 07-100-01. (hereinafter "Sending Parcel").

2. The Declarants have received approval from the Tahoe Regional Planning Agency (TRPA) on September 5, 2002 to transfer 149 square feet of Class 1b banked land coverage from the Sending Parcel to the Receiving Parcel, described as follows:

A portion of the Northwest quarter of Section 15, Township 16 North, Range 18 East, M.D.B.&M., more particularly described as follows; Parcel 1 of Parcel Map No. 426 for Boise Cascade, filed in the office of the Washoe County Recorder, State of Nevada, on May 19, 1977 as File Number 465601, Official Records.

Said parcel was recorded on July 9, 2002 as Document Number 2708680, and having Assessor's Parcel Number 132-012-05 (hereafter referred to as "Receiving Parcel").

3. Both the Sending parcel and the Receiving Parcel are located in the Tahoe Region as described in the Tahoe Regional Planning Compact (P.L. 96-551, 94 Stat. 3233, 1980), which region is subject to the regional plan and ordinances adopted by the TRPA pursuant to the Tahoe Regional Planning Compact.

4. As a condition of the above approval and pursuant to Chapter 20 of the TRPA Code of Ordinances, TRPA requires that the appropriate deed restriction be recorded documenting the transfer of land coverage and the requirement that the area on the Sending Parcel from which the coverage has been transferred shall be restored to a natural or near-natural state. The deed restriction must likewise document that the Sending Parcel must be protected from soil disturbance, and that provisions must be make for the future maintenance of the Sending Parcel.

DECLARATIONS

- 1. Declarants hereby declare that, for the purpose of calculating land coverage and applying TRPA ordinances relating to land coverage, the Sending Parcel described above is, and shall be, deemed by TRPA to have transferred and retired 149 square feet of Class 1b banked land coverage and to now contain 81,939 square feet of Class 1b banked land coverage.
- Declarant also hereby declares that the transferred coverage can never be transferred back to the Sending Parcel, and that such area shall be restored in a natural state or near natural state, which for this particular Sending parcel shall include landscaping, if not redeveloped pursuant to a TRPA permit. Declarant also declares that Declarant is permanently restricted from transferring the coverage back to the Sending Parcel. Declarant likewise declares that Declarant shall make provisions for the future maintenance of the Sending Parcel.
- 3. This declaration shall be deemed a covenant running with the land or as an equitable servitude, as the case may be, and shall constitute benefits and burdens to the parcels described above and shall be binding on the Declarants and Declarants' assigns and all persons acquiring or owning any interest in the above-described parcels.
- 4. This declaration may not be modified or revoked without the prior express written and recorded consent of the TRPA or its successor agency, if any. TRPA is deemed and agreed to be a third party beneficiary of this Deed Restriction and as such can enforce the provisions of this declaration.
