Lodato, deceased by and through Alling & Jillson, Ltd. their attorneys, having filed a Verified Petition herein on the 19th day of September 2002 and Notice of this Hearing being duly given in the manner for the time required by law, and this matter coming on regularly for hearing, and Co- Petitioners being represented by Ronald D. Alling of Alling & Jillson, Ltd. their attorneys and proof being made to the Court, this Court finds as follows:

- 1. Joseph S. Lodato died on or about the 17th day of June 2000, being at the time of his death a resident of Douglas County, Nevada.
- 2. At the time of his death Joseph S. Lodato, was a single man, and died leaving two adult children, Craig Lodato and Linda Lodato Bartlett.
- 3. Joseph S. Lodato having previously created the Joseph S. Lodato Trust dated May 18, 1993, amended and restated February 10, 2000.
- 4. The Joseph S. Lodato Trust was, pursuant to it's terms divided into two shares, one of each then living child of the Grantor, namely Craig Lodato and Linda Lodato Bartlett.
- 5. The said Joseph S. Lodato left a Will dated February 10, 2000 which was previously lodged with the Clerk of this Court and provides that all assets are to be poured into and made a part of the Joseph S. Lodato Trust.

- 6. Craig Lodato is the duly appointed and validly acting Successor Trustee of the Joseph S. Lodato Trust.
- 7. That the said Joseph S. Lodato created an ambagious document on or about the 10th day of August 1993, when he executed that certain Deed recorded on the 16th day of August 1993 in Book 893 Page 2857, Document number 315133 conveying land to the Joseph S. Lodato Trust describing the property by the correct assessor's parcel number and attaching an incorrect meets and bounds description.
- That with the recording on the 16th day of August as set forth above the said Joseph S. 8. Lodato believed he was transferring the property then described as Assessor's Parcel Number 19-042-11, now described as 1219-03-002-013 being Parcel Number 1 as shown on that certain Parcel Map for Joseph S. Lodato filed for record in the Office of the County Recorder of Douglas County, Nevada, on March 23, 1976 in Book 376 of official records at Page 1070, as document number 89067.
- 9. That the interest of Joseph S. Lodato in and to Lot 51, Block A as shown on the map of Holbrook Highlands, filed in the Office of the County Recorder of Douglas County, Nevada on March 22, 1978 as Document number 18825, APN 1022-18-002-020 should be transferred to the Joseph S. Lodato Trust, Craig Lodato, Successor Trustee.

Conclusions of Law:

The Court has the inherent equitable jurisdiction to correct a deed or other instrument and to transfer real property for the proper administration of justice.

THEREFORE, IT IS HEREBY ORDERED that the Title to the property commonly know as Parcel No.1as shown on that certain Parcel Map for Joseph S. Lodato filed for record in the Office of the County Recorder of Douglas County, Nevada, on March 23, 1976 in Book 376, of Official Records at Page 1070, Document number 89067, APN 1219-03-002-013 is hereby vested in the name of Craig Lodato, Successor Trustee of the Joseph S. Lodato Trust.

IT IS FURTHER ORDERED that an undivided two-thirds interest, (being all of the interest of Joseph S. Lodato, deceased) in and to Lot 51, Block A as shown on the map of Holbrook Highlands Subdivision filed in the office of the County Recorder of Douglas County, Nevada, on March 22, 1978


