


WHEREAS, RICHARD R. BUTLER AND GLENDA BUTLER,

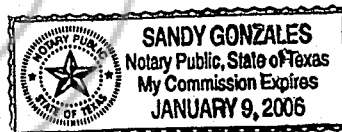
