It is hereby agreed upon by and between, Leon Mark Kizer, and PTP, Inc., that Lease No. B-208, affecting Carson City Public Domain Allotment CC-234, be modified as follows:

All the wording in Provision Number 43 "OPTION TO PURCHASE" items 1 through 13 will be deleted from the subject business lease and the following wording inserted:

"Lessee will pay the Lessor the amount of \$500.00 each instance the Lessee sub-leases a lot. For consideration of the payment of the \$500.00, the Lessor hereby agrees to allow each party who possess a sub-lease, the right to exercise the option of purchasing the sub-leased lot (including all improvements located on the lot), at any time after the end of the first twenty-five (25) year period of the subject lease term. The Lessee will pay directly to the Lessor \$500.00 each instance a lot is sub-leased, and escrow for the lot is closed. It will be the responsibility of the Lessor to provide the Superintendent, Bureau of Indian Affairs, Western Nevada Agency with proof of payment in the form of a copy of the check paid to the Lessor.

If the sub-lessee/s exercises the right to purchase the sub-lessed lot, each sub-lessee/s will pay to the Lessor a one (1) time payment of \$1,000.00 for each lot to be purchased. Prior to sub-lessee/s, making the \$1,000.00 payment to the Lessor, Lessor will take all the necessary steps to acquire a fee patent for each lot pursuant to the respective applicable federal regulations governing Indian Trust Lands. The Lessor will take this action on behalf of the sub-lessee/s at Lessor's expense. Upon acquisition of a fee patent, Lessor will convey fee title for the lot to the respective sub-lessee/s. The fee patent issued for each lot will be issued subject to any, and all valid Secretarial approved encumbrances which were approved prior to the issuance of the fee patent. The fee patent will include a right of ingress and egress to each lot, to include any, and all existing utility easements appurtenant to each lot. This action will insure any all sureties the continuance of any existing leasehold mortgages. Upon the sub-lessee/s acquisition of fee title to the lot, the sub-lessee/s lot will no longer be located within the jurisdiction of the United States Department of the Interior, Bureau of Indian Affairs, Western Nevada Agency.

The terms and conditions of the subject lease in Provision #43 (3), provided for the deposit of \$500.00 in an escrow account with a local title company each instance a lot is sub-leased and escrow is closed. Those funds were to be retained in an escrow account until such time the exercise of option to purchase was taken at any time after ten (10) years after the approval date of the subject lease. All the funds deposited in the escrow account shall be paid to the Lessor by the Lessee in compliance with the elimination of the wording in

If sub-lessee/s prefer not to exercise the option to purchase the sub-leased lot, the sublessee/s will have the ability to continue as a sub-lessee/s for the duration of the term of the subject lease with no penalty or penalties. Upon expiration of the sub-lease, the sublessee/s will have the right to approach the Lessor to enter into a new lease agreement pursuant to applicable federal regulations governing Indian Trust Lands.

The sub-lessee/s who have entered into sub-lease contracts with the Lessee prior to this modification will have the right, and ability to modify their existing sub-lease agreements in compliance with this modification if they so elect, however, if the sub-lessee/s choice is not to exercise this option, then, in that event, the sub-lessee/s will continue with their existing sub-lease agreement without any hindrance, or objection from the Lessee, or Lessor. It will be the responsibility of the Lessee to contact the existing sub-lessee/s in regards to this modification."

All the terms and conditions of this modification shall extend to and be binding upon the parties hereto, and their successors, heirs and assigns of said parties upon approval by the Superintendent, Bureau of Indian Affairs, Western Nevada Agency.

This modification does not change any terms, conditions, or stipulations in the subject lease except as set forth herein. By execution of this modification, all parties have agreed that they have reviewed the provisions and contents of this modification, and furthermore, all parties have agreed that they have had ample opportunity to have their legal counsel, or their respective representatives review the contents, and they are satisfied with the contents and have no objections.




