The general course of the lode or vein is from the south-west to the north-east direction.


The number, location and markings on each side center or corner monument are as follows:

As erected on the ground, each side center or corner monument is marked as described above by paint on post, and tag (e.g. metal tags, paint on posts).

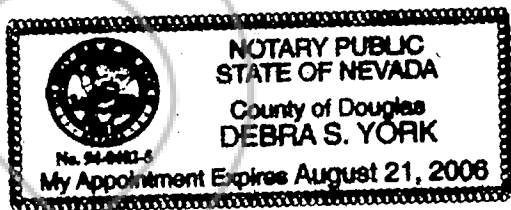
