5 of Nevada, presently held as mining claims with the Bureau of Land Management

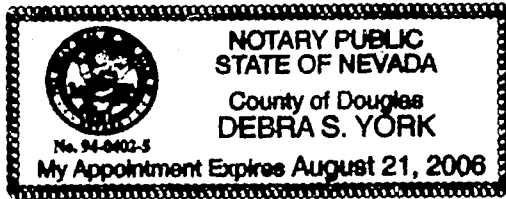
