
THEREFORE, the undersigned hereby substitutes **Wells Fargo Bank West, N.A.** as trustee under said Deed of Trust.



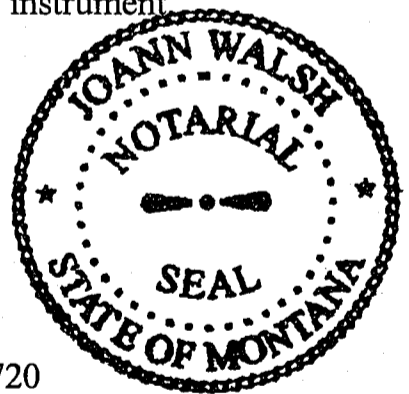
