THE PARTIES FURTHER DECLARE AND CERTIFY AS FOLLOWS:

Description of Trust

The parties hereto desire to confirm the establishment of a revocable trust on October 30, 2002, and amendments thereto, for the benefit of the Trustors (as husband and wife) and containing, *inter alia*, the following provisions:

- 1. The Trustors are designated as the Trustees to serve until both of their deaths, resignations or incompetence.
- 2. Upon the removal of both original Trustees, the Successor Trustee is designated as Danielle Marie Nickerson. In the event Danielle should fail to qualify or cease to act as Successor Trustee, then Tiffany Lee Ulrich shall act as Successor Trustee. In the event Tiffany should fail to qualify or cease to act as Successor Trustee, then Gary Verwey and Patti Verwey, or the survivor of either of them, shall act as Successor Trustee.
- 3. Upon the death of either Trustor, the net income of the Trust estate shall be distributed or applied to or for the benefit of the survivor trustor during his or her lifetime.
- Any Trustee/Trustor has the power and authority to manage and control, buy, sell and transfer the Trust property, in such manner as the Trustee may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said Trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on
