tenances, unto the said Grantee and their assigns forever.

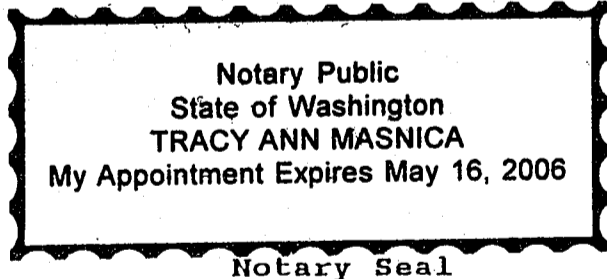
