Pursuant to NRS §111.312, this legal description was previously recorded at Document No. 193051, Book 1288, Page 2860.



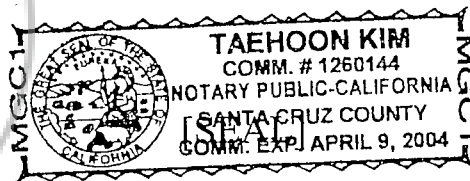
