
24 IT IS HEREBY ORDERED AND ADJUDGED that an attorney's lien  
25 in favor of KATHLEEN B. KELLY, ESQ. is established, adjudicated  
26 and granted, as is a personal judgment against Jim in favor of  
27 the Law Office of Kathleen B. Kelly, in the sum of two thousand  
28 three hundred and thirty-one dollars and thirty-four cents

1 (\$2,331.34) plus legal interest compounded monthly until paid in  
2 full. Additionally, Jim is also ordered to pay all attorney's  
3 fees and costs incurred by him in pursuit of the execution of  
4 this judgment.

5 IT IS FURTHER ORDERED AND ADJUDGED that the attorney's lien  
6 and personal judgment against Defendant may be placed of record  
7 upon Defendant's real or personal property and the Law Office  
8 Kathleen B. Kelly, shall proceed with all available execution  
9 remedies.

11 IT IS FINALLY ORDERED that movant may proceed with any and  
12 all additional methods of execution available
