That the GRANTOR, for and in consideration of the sum of ONE DOLLAR (\$1.00), lawful money of the United States of America, and other good and valuable consideration, the receipt whereof is hereby acknowledged, does by these presents grant unto the GRANTEE and to its assigns for those purposes as contained in Chapter 408 of the Nevada Revised Statutes, a temporary easement for construction access upon, over and across certain real property of the undersigned situate, lying and being in the County of Douglas, State of Nevada, and more particularly described as being a portion of the S 1/2 of Section 23, T.13N.,R.19E., M.D.M., and further described as being a portion of PARCEL 7 shown on that certain LAND DIVISION MAP for ROBERT & VAL EASTERWOOD recorded in the Office of the Douglas County Recorder, Douglas County, Nevada, on March 2, 1987 in Book 387 of Official Records, at Page 10, as Document No. 150823, and more fully described by metes and bounds as follows, to wit:


