WITNESSETH:

That the GRANTOR, for and in consideration of the sum of ONE DOLLAR (\$1.00), lawful money of the United States of America, and other good and valuable consideration, the receipt whereof is hereby acknowledged, does by these presents grant unto the GRANTEE and to its assigns for those purposes as contained in Chapter 408 of the Nevada Revised Statutes, a temporary easement for construction access upon, over and across certain real property of the undersigned situate, lying and being in the County of Douglas, State of Nevada, and more particularly described as being a portion of the S 1/2 of Section 23, T.13N.,R.19E., M.D.M., and further described as being a portion of PARCEL 7 shown on that certain LAND DIVISION MAP for ROBERT & VAL EASTERWOOD recorded in the Office of the Douglas County Recorder, Douglas County, Nevada, on March 2, 1987 in Book 387 of Official Records, at Page 10, as Document No. 150823, and more fully described by metes and bounds as follows, to wit:

BEGINNING at a point on the easterly boundary line of PARCEL 7 shown on that certain LAND DIVISION MAP for ROBERT & VAL EASTERWOOD recorded in the Office of the Douglas County Recorder, Douglas County, Nevada, on March 2, 1987 in Book 387 of Official Records, at Page 10, as Document No. 150823, 28.775 meters (94.41 feet) left of and at right angles to Highway Engineer's Station "L"27+37.205 P.O.T.; said point of beginning further described as bearing N.79° 03'19" E. a distance of 1467.938 meters (4,816.06 feet) from the witness corner for the south quarter corner of Section 22, T.13 N., R.19 E., M.D.M.; thence N.43°38'02" W. a distance of 14.749 meters (48.39 feet) to a point on the westerly ordinary and permanent high water line of the West Fork of the Carson River; thence S.83°01'00"E., along said westerly ordinary and permanent high water line, a distance of 10.385 meters (34.07 feet) to a point on said easterly boundary line of PARCEL 7; thence S.0°47'22" W., along said easterly boundary line, a distance of 9.413 meters (30.88 feet) to the point of beginning; said parcel contains an area of 48.596 square meters (523 square feet).


