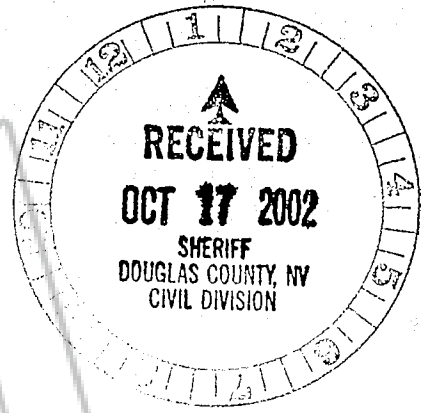

1 CREDIT must be given for payments and partial satisfactions in the amount of \$-0- which is to  
2 be first credited against the total accrued costs and accrued interest, with any excess credited  
3 against the Judgment as entered, leaving a net balance of \$ 8526.85 actually due on the date  
4 of the issuance of this writ, of which \$8,490.85 bears interest at 6.75% per annum, in the amount  
5 of \$1.59 per day from the date of Judgment to the date of levy, to which must be added the  
6 commissions and costs of the officer executing this writ.

7 NOW, THEREFORE, SHERIFF OR CONSTABLE OF DOUGLAS COUNTY you are hereby  
8 commanded to satisfy this Judgment with interest and costs as provided by law out of the  
9 personal or real property of the judgment debtor, except that for any pay period, 75% of the  
10 disposable earnings of the debtor during this period, or the amount by which his disposable  
11 earnings for this period exceed 30 times the minimum hourly wage prescribed by section 6(a)(1)  
12 of the Federal Fair Labor Standards Act of 1938 and in effect at the time the earnings are  
13 payable, whichever is greater, is exempt from any levy of execution pursuant to this writ, and if  
14 sufficient personal property cannot be found, then out of the real property belonging to the debtor  
15 in the aforesaid county, as described as follows:
