ORDER AFTER HEARING ON DRIVERS' LICENSE SUSPENSION

This matter came before the court on October 15, 2002, upon application by the Defendant, Dawn M. Artzer, appealing the recommendation of Court Master David Hardy regarding the suspension of the Defendant's Nevada drivers' license. The Defendant, Dawn M. Artzer, failed to appear at the hearing on her appeal of the Master's Recommendation. Evan Beavers, Special Deputy District Attorney for Child Support Enforcement, appeared on behalf of the Plaintiff.

This case arises from an Oregon Order requiring the Defendant to pay \$331.00 each month as and for support of Alexandria Nicole Artzer and Richard James Artzer, both minor children.

Nevada Revised Statue 425.510 mandates the suspension of an obligor's Nevada drivers' license for non-payment of child support upon the finding that the obligor owes more than \$1,000.00 for which payment is past due <u>and</u> the obligor is delinquent for not less than two months in payments for support. The court finds,

based upon the affidavits on file herein and the offers of proof made by Mr. Beavers at the hearing, that Ms. Artzer is in arrears in the amount of \$9,455.64 as of September 30, 2002. However, also upon the offer of proof by Mr. Beavers, the court finds that Ms. Artzer is no longer delinquent on her past two monthly support payments given that a wage withholding has been in effect against her Costco earnings since July 2002.

Based upon the foregoing, and good cause appearing therefore, the application to suspend the drivers' license of Dawn M. Artzer is denied. Ms. Artzer is admonished to seek the assistance of the District Attorney's Office for modification of the Oregon order to reflect the true custody status of the children at issue and to avoid continuing enforcement of an out of state order which may not be accurate as to the present facts.
