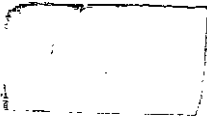
AMENDMENT TO EXHIBIT "A" OF THE



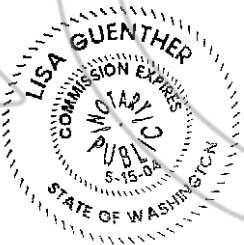
