14 A Petition for Appointment of General Guardian over the person and estate of Sandra
15 J. Danielson, an adult Ward, has been filed by Brian Danielson. A hearing on the allegations
16 of the Petition has been held. The Court having received the evidence finds as follows:

- 17 1. The Ward was born on March 4, 1941, and is presently in the care, custody or
- 18 control of Mountain View Care Center, 201 Koontz, Carson City, Nevada.
- 19 2. The Ward was served with notice of the hearing as required by law.
- 20 3. The Ward lacks the capacity to administer her own financial and medical
- 21 responsibilities, and that it is in the Ward's best interest that a general guardian of the person
- 22 and estate be appointed.
- 23 4. The proposed Ward has three known issue: Brian Danielson, Petitioner herein; Gari
- 24 Haslett, 3562 Boston Avenue, Oakland, CA 94602; and Victoria Wahner, PO Box 943,
- 25 Occidental, CA 94607. Said issue have been notified of the filing of this Petition.
- 26 5. The proposed Ward's sole income consists of social security payments in the
- 27 amount of One Hundred Sixty Three Dollars eighty four cents (\$163.84) a month, and alimony

1 payments in the amount of One Hundred Fifty Dollars (\$150) a month. She is currently
2 receiving Medicaid.

3 6. The proposed Ward's estate, estimated value less than \$50,000, consists of:

4 a. Share of residence located at 2661 Clapham, Minden, Nevada, value:
5 \$48,000, as allocated under divorce decree, to be paid into a Special Needs Trust for the
6 proposed Ward's care and benefit in accordance with the rules and regulations under federal
7 and state Medicaid statutes and regulations to enable the Ward to continue to be eligible for
8 Medicaid assistance. Establishment of said trust would not deprive the proposed Ward of care,
9 or support.

10 b. Tangible personal property, estimated value: \$500..

11 7. The Ward's debts are unknown at this time.

12 8. Due to her mental and physical illnesses, the Ward is unable to attend any hearing
13 or other conference concerning a guardianship.

14 IT IS THEREFORE ORDERED that Brian Danielson be appointed general Guardian
15 of the person and estate of Sandra J. Danielson, that Letters of Guardianship be issued to him
16 upon his taking the oath of office as required by law, that no bond be required of him; and that
17 Brian Danielson be given all powers of Guardianship of the person and estate of Sandra J.
18 Danielson.
