



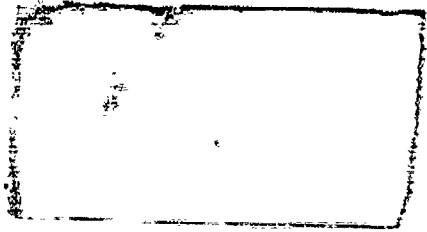


EXHIBIT "A" (28)
