SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

MARGIE JOHNSON,

THIS DEED OF TRUST, made this 12 day of February, 2003, between an unmarried woman, herein called TRUSTOR, whose address is 835 East Sierra Vista Drive, Phoenix, Arizona 85014, and MARQUIS TITLE & ESCROW INC., a Nevada Corporation, herein called TRUSTEE, and BING CONSTRUCTION CO OF NEVADA, INC a Nevada Corporation, herein called BENEFICIARY.

WITNESSETH: That Trustor irrevocable grants, transfers and assigns to Trustee in trust, with power of sale, that property in Douglas County, State of Nevada, being Assessment Parcel No. 1319-33-002-008, more specifically described as follows:

All that certain lot, piece or parcel of land, situate in the County of Douglas, State of Nevada, described as follows:

Parcel 1-A as set forth on that certain Parcel Map for Clay Kruger, located in a portion of Section 33, Township 13 North, Range 19 East, M.D.B. & M., filed for record in the Office of the County Recorder of Douglas County, Nevada, on March 29, 1985, as Document No 115403.

In the event Trustor(s) sells, conveys or alienates the within described real property; or contracts to sell, convey or alienate; or is divested of title or interest in any other manner, whether voluntarily or involuntarily, without written approval of an assumption of this obligation by the Beneficiary being first obtained, said Beneficiary shall have the right to declare the entire unpaid principal balance due and payable in full, upon written demand and notice, irrespective of the maturity date expressed in the Note secured hereby.

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

For the purpose of securing (1) payment of the sum of \$ 75,000.00 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidence by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada, in the book and at the page thereof, or under the document file number, noted below opposite the name of such county, namely:
