**SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS**

**THIS DEED OF TRUST**, made this 26th day of February, 2003, between NEAL SPROTT and DEBORAH SPROTT, husband and wife, herein called TRUSTORS, whose address is P.O. Box 2365, Gardnerville, NV 89410, and **MARQUIS TITLE & ESCROW INC., a Nevada Corporation**, herein called TRUSTEE, and THE BRAMWELL HOMESTEAD LLC., a Nevada Limited Liability Company, herein called BENEFICIARY.

WITNESSETH: That Trustor irrevocable grants, transfers and assigns to Trustee in trust, with power of sale, that property in Douglas County, State of Nevada, being Assessment Parcel No. **1420-34-610-021**, more specifically described as follows:

Lot 34, in Block 1, as set forth on the Final Subdivision Map LDA# 01-069 for BRAMWELL HOMESTEAD, filed for record in the office of the Douglas County Recorder on August 12, 2002, in Book 0802, at Page 3324, as Document No. 0549307, of Official Records.

In the event Trustor(s) sells, conveys or alienates the within described real property; or contracts to sell, convey or alienate; or is divested of title or interest in any other manner, whether voluntarily or involuntarily, without written approval of an assumption of this obligation by the Beneficiary being first obtained, said Beneficiary shall have the right to declare the entire unpaid principal balance due and payable in full, upon written demand and notice, irrespective of the maturity date expressed in the Note secured hereby.

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.


For the purpose of securing (1) payment of the sum of \$96,900.00\*\*\*\* with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidence by a promissory note or notes reciting that they are secured by this Deed of Trust.



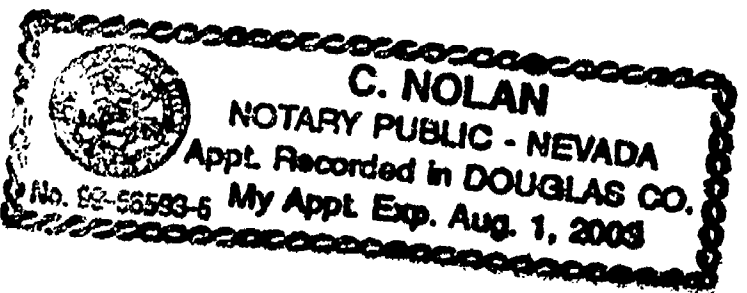
