FIRST AMENDMENT TO THE MINDEN-TAHOE AIRPORT

This first amendment to the real property lease agreement (LL074) dated October 3, 2002, is made on March 6, 2003, between Douglas County, by the Douglas County Board of Commissioners, ("Landlord"), whose address is Post Office Box 218, Minden, Nevada, 89423, and Bernie Jackson, 2321 P-51 Court Suite 404, Minden, Nevada 89423, who agree as follows:

RECITALS

This amendment is made with reference to the following facts and objectives:

- a. Landlord entered into a written lease agreement for the parcel on October 3, 2002 with Bernie Jackson. The lease is recorded as document 0554995, book 1002, pages 06648-06673.
- b. The Tenant and County agree to amend the lease to decrease the square footage of the common area, due to parking locations for proposed buildings on adjacent leaseholds, and to decrease the annual maintenance fee.

The parties agree to amend the lease as follows:

6. Rent. The last sentence after Site Rent is amended as follows:  
Tenant shall pay County an annual maintenance fee in the amount of (4,798.33 square feet x \$0.15 = \$719.75) for their portion of the common area, as shown in exhibit D, in addition to the monthly lease rent.

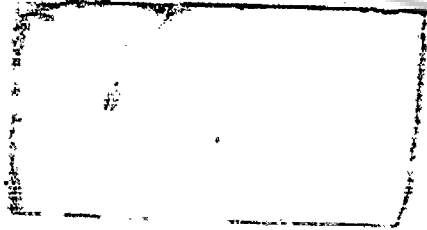

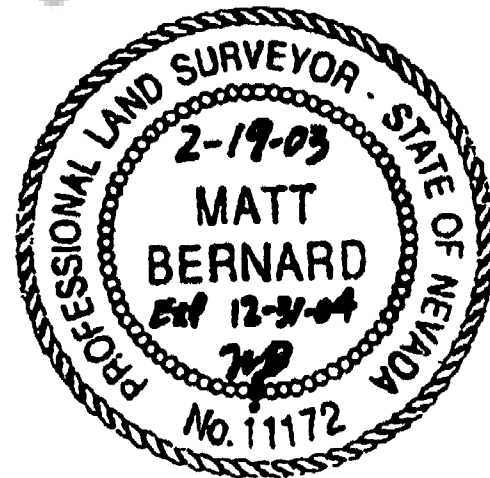

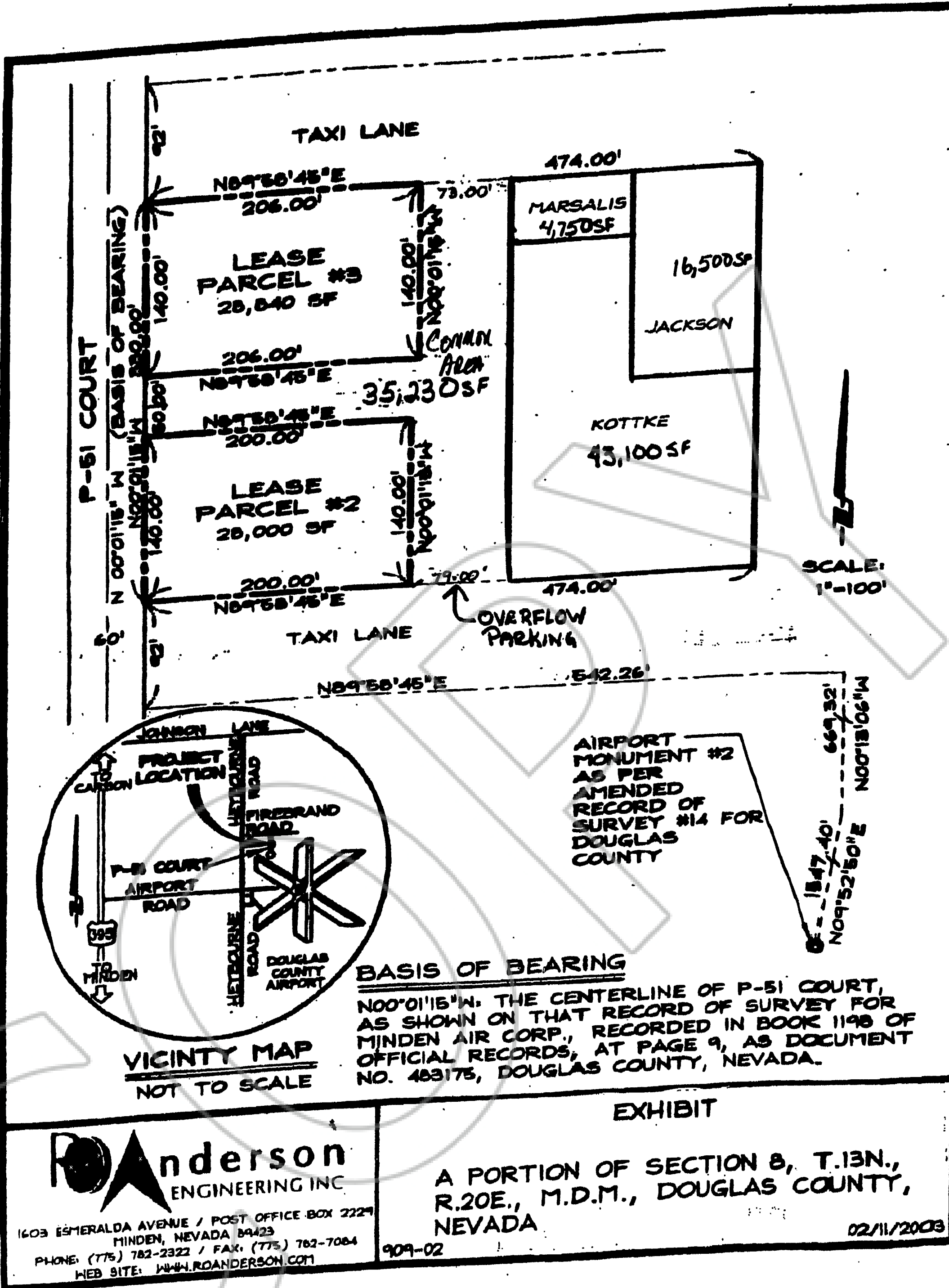
