17 This action, having been submitted to the court for decision by plaintiff's affidavit,
18 the plaintiff being represented by Douglas A. Sloane, Esq., the defendant Eric D. Jackson,
19 dba The Door Shop, a sole proprietorship having been duly served with Summons and
20 process herein as provided by law, and default having been regularly entered against said
21 defendant upon the Complaint of the plaintiff and all the records and files herein, and

23 Complaint, and the court being fully advised in the premises, and the court finding that there
24 is now due and owing from defendant Eric D. Jackson the sum of \$37,319.41 together with
25 interest thereon at the rate of 1.5% per month in the sum of \$1,274.53 as of March 12, 2003,
26 costs of \$225.50 and the sum of \$ 2000.⁰⁰ as reasonable attorney's fees to be allowed
