WHEREAS, ANNELIESE HERBIG the surviving Settlor and Trustee is competent and desires to serve as the sole trustee of the Trust pursuant to the provisions of Article 2-3.1, of the Trust agreement;

NOW, THEREFORE, in accordance with the provisions of Article 2-3.1, of the Trust, ANNELIESE HERBIG hereby assumes the duties of sole trustee of the Trust with all the powers, duties and liabilities of such Trustee.
