

Carol J. - 5. That the Administratrix, Carol J. Gallio, has preformed services in the administration of this estate for which she is entitled to a fee as fixed by statutes, but which she has waived, and expenses of \$1794.74.
- 6. That E. Sue Saunders, Esq., has rendered to Administratrix and the estate services and a reasonable fee therefor is \$2,400.00 which fee was agreed to by the Administratrix, together with her expended costs of \$165.97, and any closing costs.
- 7. That pursuant to NRS 134.100 any and all property of the decedent shall be distributed to the surviving heirs as follows:

- C. That the Administratrix be and she is hereby, authorized and directed to pay to E. Sue Saunders, Esq., the sum of \$2,400.00 for attorney's fees, together with the sum of \$165.97 for her expended costs of administration, together with any closing costs.
