20 Carol J. Gallio, Administratrix, of the Estate of Paul Huddleston, deceased, having rendered and filed on the 26<sup>th</sup> day of February, 2003 her First and Final Account, Report of Administration, Petition for Distribution, and Application For Order Authorizing Payment of Attorney Fees and Costs, and the said account and petition having come on regularly to be heard this 11<sup>th</sup> day of March, 2003, and proof having been made to the satisfaction of the Court that Notice of Hearing of said account and hearing on the Petition for Distribution and for Attorney's Fees and Costs, has been given in the manner and for the time required by law, the Court finds:

22 1. That the said account is in all respects true and correct.  
23 2. That due and legal notice to creditors of said estate has been given in the manner and for the time required by law.

That all claims and debts against said decedent and against said estate, all debts, expenses and charges of administration have been fully paid and discharged, and there are no federal estate taxes due from the estate or personal property taxed due and payable by the estate, and that said estate

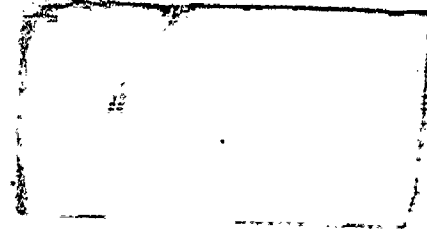
- 4. That the whole of said estate was the separate property interest of decedent.
- 5. That the Administratrix, Carol J. Gallio, has preformed services in the administration of this estate for which she is entitled to a fee as fixed by statutes, but which she has waived, and expenses of \$1794.74.
- 6. That E. Sue Saunders, Esq., has rendered to Administratrix and the estate services and a reasonable fee therefor is \$2,400.00 which fee was agreed to by the Administratrix, together with her expended costs of \$165.97, and any closing costs.
- 7. That pursuant to NRS 134.100 any and all property of the decedent shall be distributed to the surviving heirs as follows:

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED:**

- A. That the First and Final Accounting , Report of Administration, Petition for Distribution, and Application For Order Authorizing Payment of Attorney Fees and Costs, be, and the same is hereby, approved, allowed and settled, and that the facts, accounts and matters alleged and reported therein are a true, compete and correct record of the administration of said estate.
- B. That the Administratrix be and she is hereby, authorized to pay to herself the sum of \$1,794.74 for estate expenses.
- C. That the Administratrix be and she is hereby, authorized and directed to pay to E. Sue Saunders, Esq., the sum of \$2,400.00 for attorney's fees, together with the sum of \$165.97 for her expended costs of administration, together with any closing costs.

E. That after payment by the Administratrix of the above sums for Administratrix's fees, attorney's fees and costs, that said Administratrix shall deliver and set over all of the rest, residue and remainder of said estate to Carol J. Gallio and Oliver Dewey Huddleston in equal shares.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon filing of appropriate receipts, said Administratrix shall be discharged of her trust, and said estate shall be closed.
