The undersigned affiant, in propria persona in my own proper person, sui juris with all my rights of a freeman, being put upon due and solemn affirmation before the undersigned witnesses, hereby deposes and states:

- 1. My name is Carl Hans Andersen. I am over the age of twenty-one years.
- 2. Whereas, it is a fact that Carl Hans Andersen has no oath's-no contracts with Barry Sabragia, Scott Evans, or the DEPARTMENT OF THE CALIFORNIA HIGHWAY PATROL, or the DEPARTMENT OF MOTOR VEHICLE'S, or the TOWN OF PARADISE POLICE DEPARTMENT- its Council, or BUTTE COUNTY BOARD OF SUPERVISIORS, or it's BUTTE COUNTY SHERIFF' DEPARTMENT Perry Reniff, or the UNITED STATES, or any and all of the men names unknown and unnamed-assembled on march 5, 2003 at or about 9:30 a.m. to 10:15 a.m.- behind 6194 Skyway-Paradise California whom did "Trespass" and then did- "Commit Robbery-Sec.59 div.7 April 19, 1856 Robbery-the felonious and violent taking of-keys to a green Ford F-150 truck, a Green Ford F-150 truck, tools, rotor teller, Milwaukee Drill Motor, with force and intimidation-with weapons" and then did commit- "Grand larceny-Sec.60-div.7 April 17, 1856 feloniously steal, take, and carry, lead or drive away the personal goods or property of another, of the value of fifty dollars or more"-personal property in the custody of Carl Hans Andersen. And
- 3. Whereas, it is a fact that on March 5, 2003 on or about thirty minutes passed Nine O'clock AM affiant stopped on Starlight Drive to assist a man-a military officer from the Department of the California Highway Patrol-known latter to be one Barry Sabragia. And
- 4. Whereas, it is a fact that Barry Sabragia said something about having a license plate on the front of a vehicle and ask about some form of a contract which confused affiant and affiant did not understand. And
- 5. Whereas, it is a fact that affiant said and ask Mr. Sabragia "Gee, I'm a little confused and I don't understand. Under Law, California Constitution 1849 which Article do you make this request from?" And

- 6. Whereas, it is a fact that Mr. Sabragia raised his voice, ask the same question- with obvious intent to intimidate affiant and confuse and coerce affiant further with military tactics-loud-obnoxious-threating-rude-disrespectful- manner and mannerism. And
- 7. Whereas, it is a fact that affiant- again- said and ask Mr. Sabragia "Gee, I'm a little confused and I don't understand. Under Law, California Constitution 1849 which Article do you make this request from? And
- 8. Whereas, it is a fact that Mr. Sabragia went inside his vehicle. And
- 9. Whereas it is a fact that affiant went to his vehicle retrieved a cell phone and made a phone call while walking down Starlight Court toward Neal Road-approximately one hundred yards to get the name of the street while phoning for assistants because of Mr. Sabragia's irrational-irresponsible-erratic and disrespectful behavior. And
- 10. Whereas it is a fact affiant returned to the truck to put the phone away-he noticed the keys where missing and begin to look for them in his pants pocket- and coat. He walk over to where Mr. Sabargia was standing and looked on the ground but did not see them. He walk back over again and looked in the truck but did not find the keys. He then walk back to where Mr. Sabragia was standing and ask him if he had taken the keys to the truck and which Mr. Sabragia said "yes". And
- 11. Whereas it is a fact that affiant ask Mr. Sabragia to "Please return the keys immediately"-and he said "No". And
- 12. Whereas it is a fact that affiant said to Mr. Sabragia "I demand that you return the keys immediately to me sir"-and he said "No". And
- 13. Whereas it is a fact that affiant ask Mr. Sabragia "Under California Law Constitution 1849 which Article and section do you deprive me of the personal property". Mr. Sabragia refused to answer. And
- 14. Whereas it is a fact that affiant, then and there, stated and said "Sir you are under citizens arrest for robbery taking through force and intimidation the keys I demand you return the keys now." And
- 15. Whereas it is a fact that Mr. Sabragia again refused to return the keys. And
- 16. Whereas it is a fact that affiant told Mr. Sabragia that he was under citizens arrest again for robbery and Mr. Sabragia refuse to return the keys and submit to arrest.
- 17. Whereas it is a fact that Mr. Sabragia said "I could arrest you". And
- 18. Whereas it is a fact that affiant ask Mr. Sabragia "Under California Law Constitution 1849 which Article and section do you intend make this arrest under and for what?" –at which Mr. Sabragia refused and failed to answer. And

- 19. Whereas it is a fact that affiant demanded Mr. Sabragia return the keys again and that he was under arrest at which Mr. Sabragia said "Go ahead and arrest me!" in a baiting-taunting-coercing voice and manner trying to lead and engage affiant into a fiscal duel-fight. And facts are-three times Mr. Sabragia tried this tactic and affiant responded by saying-"Standup give me your handcuffs turn around and but your hands behind your back."- at which Mr. Sabragia refused therefore resisting arrest by failing to comply. And
- 20. Whereas it is a fact that affiant at that time realized that nothing could be accomplished without a breach of the peace and violence, therefore, in an act of recaption-turned-walk back to the truck-and said "Have a nice day"-got in the truck-lock the doors-started the truck with a second set of keys, and traveled the post roads toward 6194 Skyway Paradise California-to a save haven. And
- 21. Whereas it is a fact that affiant in his travel-turned right on Neal Road-heading toward Skyway- called on his Cell phone the emergency phone number for assistants form the Sheriff's office of the county of Butte to assist in the arrest. And
- 22. Whereas it is a fact that affiant after requesting and demanding- from the 911 dispatch person- to be patched through to the sheriff- was not patched through to the Sheriff, instead was yelled at by a hysterical woman to "stop the car"-several times-at which time affiant hung up the phone, and which he received no help or assistants at all ever from the Sheriff's office of the county of Butte, the supreme Law enforcement in the county of Butte. And
- 23. Whereas it is a fact that affiant drove up Neal Road to the Skyway-stopped at the light-turned northeast on the skyway going into town-stopped at the Pearson Road and Skyway-stoplight-waited for the light to turn green-and traveled to the rear of 6194 Skyway-where affiant would have a save and secure civil power environment from the robbers and Military armed force of California-got out of the truck-put the keys of the truck on the floor-locked the doors and closed them-walk over to a black car- pointed to Mr. Sabargia and said to the other men standing around-with guns-drawn directed at affiant-"That man is under citizens arrest for robbery the taking with force and intimidation with a weapon" at which time affiant was taken vi et-armis-handcuffed and ask to stand with his back to California Highway Patrol car. And
- 24. Whereas it is a fact that affiant-upon being deprived of his liberty under Law-California Constitution 1849 Article I Section 1, said "I demanded to be taken forthwith before a Magistrate". And
- 25. Whereas it is a fact that Mr. Sabargia and the other men unknown stood around and talked where affiant could not here them conspiring there next moverather than communicate with affiant. And
- 26. Whereas it is a fact that a Sergeant Scott Evans came on the scene and talk to Mr. Sabargia within affiants view-but affiant could not here what was being said-at which time affiant said "why don't you gentleman come over here so we can all talk about this." which Sergeant Evans and Mr. Sabargia ignored. And

- 27. Whereas it is a fact that no Sheriff deputy or military officer placed Mr. Sabargia under arrest-took him to the Sheriff jail in Oroville, and to the best knowledge of affaint, Mr. Sabragia is still at-large- armed with a weapon- a public nuisance-and a danger to the public peace-. And
- 28. Whereas it is a fact that affaint said-clearly and concisely to Sergeant Evans-Mr. Sabargia- and all the other armed men "You are denied any and all power of attorney to take or do anything with that private property- the truck". And
- 29. Whereas it is a fact that affiant was then place in the car with the very man whom affiant had placed under citizen's arrest and whom had robbed-threaten-affiant- and attempted to lead and bait affiant into a fiscal duel-fight. And
- Whereas it is a fact that affiant sitting in a car- hand cuffed-and with other **30.** men and women in the community standing nearby-watched Sergeant Scott Evans and other armed man unknown and unnamed from the DEPARTMENT OF CALIFORNIA HIGHWAY PATROL- from the TOWN OF PARADISE POLICE DEPARTMENT- from the BUTTE COUNTY SHERIFF'S DEPARTMENT standing by-assisting-and witnessing - the unlawful entry into the truck using the stolen key-robbed from affiant by Mr. Sabargia- did violate "Constitution for the United States of America- Article The Fourth-The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures..." and the "Constitution of California 1849 Article I Section 19. Whereas it is a fact that affaint was at around 50 minutes passed 9 o'clock-taken-vi et armis-againiat his will-by Mr. Sabargia-the very man whom was under citizen's arrest-and whom resisted arrest-and whom attempted to bait-coerce-challenge-lead affiant into a fiscal duel-fight-and the very man whom had deprived affiant of life, liberty, property, safety, happiness-and-due process of Law-defined at "Constitution of California 1849 Article I Section1- Article I Section 8- Article I Section15- Article I Section16- Article I Section18- Article I Section19- Article I Section21", to the butte county jail-via car-usurping all limitations upon him and authority of law. And
- 32. Whereas it is a fact that affaint was never informed that he was under arrest for any violation of California law- Constitution of California 1849 Article Section or Statutes. And
- 33. Whereas it is a fact that affaint-sitting in the front seat-inside Mr. Sabragia's car-handcuffed-watched Scott Evans-open the lock to the Green F-150 Ford truck-with the electronic key-open the door with the key-did activate the alarm-then deactivated the alarm with the electronic key-then entering the truck, and then affiant was taken away in the car piloted by Mr. Sabragia. And
- 34. Whereas it is a fact that affaint while traveling to Oroville with Mr. Sabragia, affiant requested to be taken forthwith to the magistrate again, but was denied. And
- 35. Whereas it is a fact that affaint was taken into the jail by sheriff deputies, at which time affiant said "I demand to be taken to the magistrate forthwith" and pointing to Mr. Sabragia said "This man is under citizens arrest for robbery taking with force and intimidation and is remanded into the sheriff's custody", at which the sheriff deputies fail to comply with a citizens arrest. And
- 36. Whereas it is a fact that the sheriff deputies- under the direct command of Perry Reniff-Butte County Sheriff- and the BUTTE COUNTY BOARD OF SUPERVISORS, did rob affiant of "two-20 FEDERAL RESERVE NOTES, and, one-10 FEDERAL RESERVE NOTE, and one-1 FEDERAL RESERVE NOTE and never did return them to affiant therefore committing the crime of Robbery. And
- 37. Whereas it is a fact that affaint demanded three or four times to be taken forthwith to the magistrate-and was denied and ignored by the Butte County Sheriff's Deputies. And
- 38. Whereas it is a fact that affaint requested from the sheriff deputies some paper and a pencil to write a writ of habeas corpus on, and was given a-three to four inch long dull pencil without an eraser- and a little piece of paper-three inch by three inch yellow sticky pad paper, which is clearly and concisely and intentional-threat to and a depriving of liberty-a usurping of limitations-a denial of due process Constitution of California 1849 Article I Sec. 8. And
- 39. Whereas it is a fact that the Butte county Sheriffs deputies acting as agents for Perry Reniff- and for the Butte County Board of Supervisors did-engage the services of affiant-for his photographic images and his finger and hand prints from

his left and right hands for the fees of one million dollars-payable to affiant or affiant's assigns within ninety days of releasing affiant. And



- 43. Whereas it is a fact affiant called the parties whom had robbed and stolen the property in affiant possession—Scott Evans-Barry Sabragia- and Skyway Towing-Ceil (last name unknown)—Joy Ann Weston, to regain possession of the property robbed from affaint. And
- 44. Whereas it is a fact affiant and David Clemens traveled to the office of Scott Evans-Barry Sabragia in Chico California to acquire a written document to retrieve the private property-after and only after affaint would pay embezzlement and exaction demands. And
- 45. Whereas it is a fact affiant regained possession of the robbed property by paying embezzlement and exaction demands of two hundred and five Federal Reserve Notes, demanded and authorized-by Scott Evans-to Skyway Towing- to release the property in custody of affaint, to affaint's friend-David Clemens. And
- 46. Whereas it is a fact affiant when examining the interior of the Ford F-150 truck-found that Scott Evans and another man unknown and unnamed had tampered with-opened and examine mail of affaint- and mail not belonging to affaint without authority-under color of law/authority- and in violation of California Statutes. And

Whereas it is a fact that Barry Sabragia, Scott Evans and the Butte county Sheriff deputies did unlawfully trespass against Carl Hans Andersen-by depriving him of life, liberty, happiness, property-without Due process of law-by there usurping the long established customs of the people of California-and there most scared of rights-Section 1-and Section 8 of Article I-Constitution of California 1849, by incarcerating him for five hours and property in his custody for nine hours- without informing affiant of the nature and cause-without due process of law.
