**WITNESSETH:**



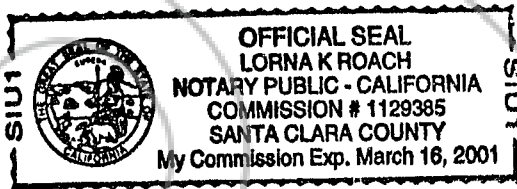
