- 10. Pursuant to NRS 134.060, the property of the Decedent should be distributed to her surviving brother.
- 11. That the Petitioners, Mary R. Craggett and Collin Douthit, waive payment of the statutory Coadministrators' fee in the sum of \$7,589.61.
